From the Associate Dean Research

Maintaining high standards of research integrity is integral to research and research training processes in the Faculty of Built Environment. UNSW is currently reviewing its various codes and practices and it is intended to move from the current 'rule-based' Research Code of Conduct towards a more 'principles-orientated' approach. Providing a model is the Singapore Statement on Research Integrity (originally drafted in 2010) which is based around four main values: honesty in all aspects of research, accountability in the conduct of research, professional courtesy and fairness in working with others, and good stewardship of research on behalf of others. These will be elaborated in a raft of responsibilities covering research methods, authorship, peer review, public communications, ethical protocols, supervision and mentoring, collaboration and conflicts of interest. Any possible breaches of these principles, however inadvertent and innocent, are dealt with very seriously by the University. Fortunately they have been rare in Built Environment and that's hopefully the way of the future. Highlighting the review process provides a timely reminder for staff and research students to visit the research integrity pages on the UNSW Research Gateway (<https://research.unsw.edu.au/research-integrity-policies-and-procedures>). The review process to be rolled out will be consultative and give all stakeholders the opportunity to comment on and shape the final statement of best-practice principles.

Proposing Changes to the UNSW List of Top Quality Outlets

Thank you to everyone in the faculty who submitted proposals to add items to the UNSW lists of top quality outlets. These lists will inform the university's new measure of research performance which is being trialled through 2014 and 2015.

Despite the tight deadline imposed by the PVCRA, 49 submissions were received, comprising proposals to add

- 10 book publishers
- 11 conference proceedings
- 17 journals
- 10 non-traditional creative outlets
- 1 standalone output.

The proposals are now being reviewed by the ADR before being forwarded for central assessment, with outcomes due to be notified on 1 October.

Meet the Researchers – Dr Christine Steinmetz



Christine is a Senior Lecturer in the Bachelor of Planning program. Since taking up a lecturing position in 2009 she has taught first, second, fourth and fifth year students. Currently she teaches a first year introduction to planning course, qualitative research methods, and co-teaches the final year thesis project with Dr Gethin Davison. In addition to supervising undergraduate theses, Christine has six PhD students and two masters students.

At the heart of her research interests are the complexities of people and place experiences. Her recent research focuses on adult entertainment and commercial sex industries in Sydney—the planning and regulation around these land uses, progressive and best models 'in practice' from a global perspective, and the significant contribution commercial sex brings to a night time economy. Of central concern are the impact of and on surrounding urban environments, the role of various stakeholder groups, subcultural sex-on-premises venues and the regulatory framework that surrounds them.

Christine has a book coming out in October 2014 to be published by Routledge called *(Sub)Urban Sexscapes: Geography and Regulation of the Sex Industry*. She will have four chapters in the book, co-edited by Dr Paul Maginn of University of Western Australia.

Christine is now broadening her knowledge of contentious land uses to include telecommunications and has recently had an abstract accepted for a Special Issue of *Australian Planner* on telecommunications.
