## Description

This course focuses on interior space as a site of constructed identity. The role of interior architecture in codifying and reproducing social identities will be explored through an historical, cultural and theoretical investigation of a range of typologies including civic and corporate.

## Aims

The course aims to generate an awareness of the origin and purpose of strategies employed by Interior architects and designers, over time and within varying cultural contexts, in the design of interior architectural environments that are concerned with the projection of social identity, notably those broadly categorised as civic and corporate. Additionally, the course aims to consolidate students skills in research, analysis and critical thinking as well as their understanding of how those skills inform design practice.

## Course Learning Outcomes (CLOs)

At the successful completion of this course, you will be able to:

1. Interrogate and describe the potential of the investigated typology and the context of its evolution historically.
2. Develop an in-depth understanding of a research topic through comparative analysis and critique.
3. Synthesize knowledge and ideas derived from theoretical investigation into a sophisticated written argument.
4. Communicate that argument at an advanced level.
5. Theorise and propose ways in which research can inform interior architecture practice.
